**NOTICE OF DEPOSIT OF REVISED PROPOSALS FOR THE REPLACEMENT OF
A LOCAL PLAN**

SECOND DRAFT OXFORD LOCAL PLAN 2001-2016

Oxford City Council have revised the proposals for the replacement of the Oxford Local Plan 1991-2001 and First Draft Oxford Local Plan 2001-2016. If, and when, this revised plan is adopted it will form part of the development plan for the area of Oxford City Council. The development plan forms the basis for decisions on land use planning affecting that area.

Copies of the revised plan are available for public inspection, free of charge, at the following locations:

- Central Library, Westgate, Centre for Oxfordshire Studies, 2nd floor, Oxford OX1 1DJ, Monday, Friday and Saturday 9.15 am to 5.00 pm, Tuesday and Thursday 9.15am to 5.00pm, Wednesday closed.

Objections to, and representations in respect of, the revised plan should be sent in writing to the **Planning Policy Manager, Ramsay House, 10 St. Ebbes Street Oxford OX1 1PT before 5.00 pm on Friday 4th April 2003**. Objections and representations should specify the matter to which they relate and the grounds on which they are made. They may also be accompanied by a request to be notified at a specific address of the withdrawal, adoption, approval or rejection of the plan. Objections may only be made in respect of those parts of the plan which have been revised since the original plan was made available on 28th June 2002.

Only objectors whose objections are made in writing and arrive at the address specified above within the six week period ending on Friday 4th April 2003 will have a right to have their objections considered at the local inquiry or other hearing.
